

Consent for the processing of personal data and the rights of an individual

By providing data for employment in accordance with the Personal Data Protection Act and the General Regulation on Data Protection (hereinafter GDPR), I voluntarily give explicit consent to Pipistrel d.o.o., Goriška cesta 50A, 5270 Ajdovščina, Registration No. 5672767000, Pipistrel Vertical Solutions d.o.o., Vipavska cesta 2, 5270 Ajdovščina, Registration No. 7254466000 and Pipistrel Italia s.r.l., Via Fratelli Rusjan 26, 34070 Savogna d'Isonzo, Italy, to collect, store, and process personal data from the application form for the purposes of any possible employment in those companies, for which I gave an explicit consent.

I am aware that the consent for processing of my personal data for the abovementioned purposes is not a prerequisite for the conclusion of an employment relationship for a particular job vacancy.

By submitting my personal data to the application form, I confirm that I am aware of my rights regarding the transmitted personal data, and that I have the right, in accordance with Personal Data Protection Act and GDPR, to:

- request access to my personal information,
- request correction or deletion of personal data or processing restrictions regarding me, and that I have the right to object to the processing and the right to transfer data,
- revoke my consent at any time by sending a notice by e-mail,
- file a complaint with the Information Commissioner.

By submitting my personal information in the application form, I confirm that I am aware of the following:

- the Data processor will process the mentioned personal data exclusively for the purpose stated above, until I revoke the authorization,
- based on the information provided, there is no automated decision-making,
- personal data is retained until revocation of permission.

2. The purpose for which the personal data are processed, the legal basis for their processing, and the retention period

Personal data transmitted are processed for the purpose of possible employment by the processors. This means that, in the case of a vacancy, the processor will look at the personal data transmitted, and, if you fulfill the conditions for occupation of current vacancy, contact you in that regard.

Transmitted personal data is stored until your consent to the processing of these data has been withdrawn. You can withdraw the consent at any time by sending an email to info@pipistrel.si. Withdrawal of consent shall not affect the lawfulness of processing based on consent before its withdrawal.

We process this personal data on the basis of your valid consent (Article 6(a) of the Regulation) until the withdrawal is given. When filling in the data form, clicking on the "Submit application" button confirms that you

agree for processors to process your personal data submitted for the purpose of any employment, and that you are aware that you can withdraw the consent for such processing at any time.

3. Users of personal data:

There are no external users of personal data.

4. Transfer of personal data to a third country or an international organization:

Personal data is not transferred to third countries or international organizations.

5. Individual rights:

You have the right to request access to personal data and the correction or deletion of personal data or the processing restrictions associated with it, and the right to object to the processing and the right to transfer data. Your request is treated in accordance with the provisions of the General Data Protection Regulation. 6. Is the provision of personal data a statutory or contractual obligation or an obligation that is necessary for the conclusion of a contract and whether the data subject must provide personal information and what are the possible consequences if such information is not provided

The decision to send personal data from the application form to is voluntary, which means that you yourself decide whether or not you will provide us with this information. The transmission of this information is not a requirement for occupation of the job vacancy, to which you can apply in the manner specified in each tender. Based on the information that it provides when submitting the application form, the processor may decide whether you qualify for the occupation of a job vacancy at the processor.

7. Automated decision-making or profiling is not carried out.

9. Will my personal data be transmitted to third parties?

The listed companies will, at your request, allow you, in accordance with applicable law, to view personal data, copy them or print them out as regards data relating to you. Also, upon your request, in accordance with applicable law, you will be provided with other information related to your personal data that are being processed.
